Regional Updates

Over the course of the past couple of weeks we've been conducting our annual regional updates. These updates serve a few key purposes. Workload

Arbitration/Lawsuit

We continue to engage in settlement talks with the system office and the attorney general's office regarding the unfair labor practice lawsuit we filed following the system's refusal to apply the terms of the workload arbitration ruling going forward. These situations always take longer than anyone wants, and they tend to ebb and flow during that time, but we continue to work toward a settlement that reflects the arbitrator's ruling. As soon as we conclude settlement talks, with or without a settlement, we'll let you know, and we'll be making campus visits to meet with those affected.

Reimagining Minnesota State

Reimagining Minnesota State is an initiative coming out of the system office and the Board of Trustees that seeks to address questions over MinnState's role as a system of higher education and what changes are needed to best serve the people of Minnesota. Since first hearing about this last

summer, we have watched this initiative evolve over several iterations, from a version that was fairly top-down and mainly interested in learning about how corporations and businesses innovate and disrupt, to a version that more broadly seeks to articulate where higher education is right now and where it can go.

We hope this evolution means we are not about to repeat the Charting the Future endeavor all over again. As the Reimagining initiative continues to take shape, the feedback we've given to the system (and will continue to give) is that amazing, innovative things happen every day on our campuses with our students. If this initiative is serious about truly articulating the value MinnState brings to the residents of Minnesota, it has to be serious about understanding the innovative work that we—the faculty—are already doing and asking how we can make sure the system truly supports our efforts. We obviously believe we have an important place in these conversations, and as this process takes its final form, we'll be trying to find ways that our faculty can bring the best of what we do into the process and share our view of where we can go next. Stay tuned for opportunities to participate and more information on where this process is going.

Membership

Last year, in anticipation of the Supreme Court ruling against unions in the Janus vs AFSCME case, we conducted a statewide membership effort - our Yellow Card campaign. Your work on this campaign and related activities such as the Early Enrollment initiative, the Member Organizer Development Program, and outreach this fall to new members, has proved incredibly successful. Far from being a crippling blow, the Janus decision has only served to energize and invigorate our members and our efforts, and we see this in the numbers. With new member gains from last year's efforts offsetting post-Janus drops, our initial net loss of membership was only 1.5%, nowhere near the double digit losses many predicted. But we are not done. It is a post-Janus world, and preventing the slow drip of membership loss will be an ongoing concern. To address this, the membership committee with a \$10,000 grant from Education Minnesota, will be conducting a series of trainings focusing on the foundation of all member engagement work – the one-on-one conversation. By building relationships, identifying issues, and creating engagement opportunities, we will continue to build our capacity and secure our future. Thank you to everyone who has been and continues to be involved in these efforts.

Budget/Dues Planning

The executive committee is working on what the organizational structure and budget will look like going forward in a post-Janus world. With the loss of approximately \$250,000 from fair share fees going away and a dropping of membership, we will be looking at either paring back the budget, changing the dues structure, or a combination of both. The executive committee is examining what we believe to be the values of the organization and going forward accordingly. This could mean changes in release credits, committee work, Delegate Assemblies, Summer Leadership, etc...

The Dues Workgroup that was created by a vote at the board meeting following the Delegate Assembly is looking into a dues structure change. Initial findings would suggest a Salary Based Dues structure based on a percentage of total salary. The findings, suggestions, and arguments for the change will be explained at the December 7 Board of Directors meeting. Each chapter's board representative will be tasked with bringing the information back to the faculty for feedback. We will have another discussion regarding this at the Delegate Assembly and will be asking the Board of Directors to act on a motion regarding dues. Please be present at those MSCF faculty meetings to have your voice heard.

Bargaining

MSCF has sent a letter to Minn State conveying our wish to open up the Master Agreement for negotiations. Our team has met twice so far this fall, with the intent to create a survey.

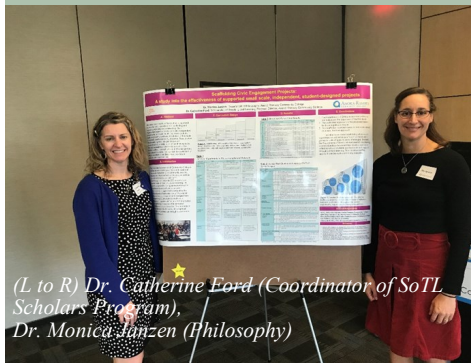

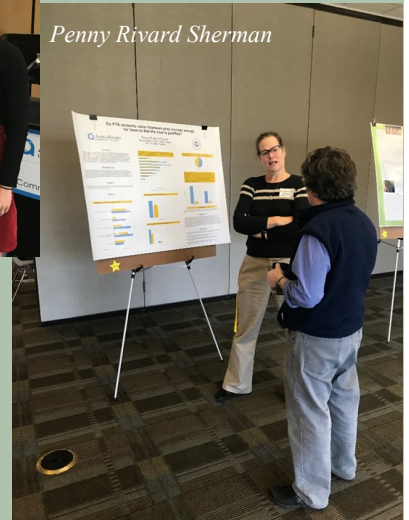
